STATEWIDE BALLOT MEASURES

Proposition 1: Veterans & Affordable Housing Bond Act. Authorize \$4 billion in general obligation bonds for housing-related programs for Veterans. Recommend: **Vote YES**

Proposition 2: No Place Like Home Act of 2018. Permanent supportive housing & mental health services for persons who are experiencing homelessness. Recommend: **Vote YES**

Proposition 3: Water Supply & Quality Act. Funds for for water infrastructure, groundwater supply & storage, dam repairs, watershed & fisheries improvements, habitat protection & restoration. Recommend: **Vote YES**

Proposition 4: Children’s Hospital Bonds Initiative. Funds go to children’s hospitals for construction, expansion, renovation, & projects. Recommend: **No Recommendation**

Proposition 5: Property Tax Transfer Initiative. Property tax loophole for assessments, with a possible lower tax adjustment for interest groups. Recommend: **Vote NO**

Proposition 6: Repeal of Senate bill 1. Devastating elimination of funding for more than 6,500 bridge & road safety, transportation & public transit improvement projects underway throughout California. Recommend: **Vote NO**

Proposition 7: Permanent Daylight Saving Time Measure. Recommend: **No Recommendation**

Proposition 8: Fair Pricing for Dialysis Act. Improves dialysis patient care, Protects taxpayers. Recommend: **Vote YES**

Proposition 9: Three States Initiative. (Blocked by courts.) Recommend: **Vote NO**

Proposition 10: Affordable Housing Act. Repeals repealing the Costa-Hawkins Act, help renters stay in their homes. Recommend: **Vote YES**

Proposition 11: Emergency Ambulance Employee Safety & Preparedness Act. Ambulance workers on-call during breaks, Recommend: **Vote NO**

Proposition 12: Farm Animal Confinement Initiative. Updates previous proposition passed by voters to defining prohibited confinement of farm animals. Recommend: **Vote YES**
